
- Xx questionnaires were distributed with the February issue of the News

- The survey was advertised in the Parish News, including a reminder





Overall Use of Village Facilities
















The village has sufficient housing to meet current and future housing need.



Some small-scale development of new homes would be good for the village.




Are you considering moving to a smaller home within the next 10 years?




Transport methods used by residents




Daily Transport Methods




Are the public transport options sufficient?

















Some village roads would benefit from measures to reduce speed






Safer routes for pedestrians and cyclists would be helpful






Small businesses within the village should be supported and encouraged to remain in Edington




It would be good to encourage more visitors to Edington




If you work from home please indicate how often



Is mobile phone coverage sufficient in Edington




Is broadband speed sufficient in Edington



Conclusion

In light of the Government's announcement on major changes to the planning system, the NP Group discussed this at their meeting on 20th August 2020. The following was proposed.

CONCLUSIONS

- 1. That the PCC should take the lead role and become more involved.
- 2. The NP Group consider they do not have the right skill set to formulate and execute such an important document.
- 3. The time scales are woolly and do not give an end date nor focus for the group.
- 4. The NP group have studied the West Lavington NP which was finalised in June 2019. It is evident from this plan that we are only just beginning.
- 5. The NP group believe that each individual working group for the Plan should advance as far as possible out of respect to the villagers' views. Possibly with the exception of the Housing Group.

Recommendations

- 1. That the work on the Neighbourhood Plan should continue in order to maintain momentum and respect the efforts villagers who completed questionnaires.
- 2. PC to review the West Lavington NP, which engaged Impact Planning Services Ltd., Swindon, Tel: 01793 820158. Consultant Mr. Jeremy Flawn.
- 3. A member of PC to contact a member of West Lavington PC to establish whether:
 - Impact Planning as a company were easy to work with.
 - Was the consultant informed and able to see the village 'vision'.
 - Were they value for money.
 - Would they recommend Impact Planning.
- 4. A PC member to sit on each of the NP working groups (as achieved with the Edington Plan), to give more input and guidance.
- 5. PC to recommend achievable time lines/road map/end date.
- 6. PC and NP group to recruit individuals to the working groups.
- 7. PC to inform the village of current progress.
